2	Whether the equipment repair works have to be done by contractor	<b>Yes</b> , Minor repairs have to attend by contractor (As per section –V Point No. 29) & Point No. 01)
3	Whether the surrounding areas have to be cleaned by contractor or client	Before handing over of STPs to contractor, the areas will be cleaned by CUTN. After taking over of STPs by Contractor, it must be cleaned frequently (As per Section –I Point No. 10).
4	Whether the testing charges included or excluded in the tender document	The costs of testing charges are included.(As per Section –I Point No. 8)
5	Whether the minor repairs are to be done by client before handing over	<b>Yes</b> , minor repairs will be done by CUTN before handing over.
