1	Whether EMD is relaxed or not	(i) All the Bidders are exempted for furnishing EMD as per Ministry of Finance, Department of Expenditure, Office Memorandum No. F.9/4/2020-PPD dated 12.11.2020. Hence, the Bidder shall furnish, as part of their bid, a Bid Security declaration in lieu of EMD as per Annexure- A . (ii) The firms who are registered with National Small Industries Corporation (NSIC) / or Small Scale Industrial (SSI)/ Micro, Small & Medium Enterprises (MSME) shall submit a self attested photocopy of valid registration certificate issued by competent authority with the technical bid (if applicable). (iii) Any bid not accompanied with the Bid Security declaration shall be rejected by University.
2	Whether Performance Security is relaxed or not	As per Ministry of Finance, Department of Expenditure, Office Memorandum No. F.9/4/2020-PPD dated 12.11.2020, the successful bidder (i.e. contractor) shall deposit an amount equal to 3% of the value of the contract instead of 10% as given in Tender document.
3	Whether bidders should submit copies of ESI, EPF registration or not	Refer section-I of Tender document page no. 07 of 43 point no. 09
4	Submission of Labour license, LIN Number	Refer section-III of Tender document page no. 12 of 43 point no. 38
5	Whether original documents of earlier submitted tender Ref. No: CUTN/ENGG/CVL/Tender/2020-21/04 will be returned or Not.	After receiving request letter from bidders, the original certificates will be returned, if any not signed by committee.
