The details of the agency/profile should be furnished along with the copy of all related documents.
3. Read through the terms and conditions given and affix your signature and seal if you find them acceptable. Any deviations may be recorded. Read carefully list of specifications that we have enclosed.
4. Fill in the questionnaire regarding the Firm.
5. The downloaded documents '**Technical Bid**' and '**Financial Bid**' should be **TYPE WRITTEN USING CAPITAL LETTERS ONLY**. At the time of filling the "**Financial Bid**" make sure that you have not missed anything. Specify the Brand, model & specification for each item. The form should be filled item-wise. Do not leave blank fields. If you are not quoting for a specific item, you should specify "**NOT QUOTING**".

5. The rate quoted should be on **unit basis** excluding Taxes. Taxes and other charges should be quoted separately, considering exemptions if any.

12. Rate should be clearly quoted in both in figures and words in respect of each item. Rate should be quoted inclusive of all taxes.

Any attempt by any vendor to bring to bear extraneous pressures on us shall be sufficient reason to disqualify the vendor. 15. We are not responsible for accidental opening of the covers that are not properly super scribed and sealed before the time scheduled for opening.
16. Authorized signatory should sign on all the pages. Bids without authorized signatures or seal of the firm will be rejected.
