

Minutes recorded at the Pre-Bid Meeting for **Outsourcing of Gardening and Housekeeping Services to Central University of Tamil Nadu, Thiruvavur.**

Sl. No.	Query	Reply
1	Bidders requested to increase the minimum percentage of Service charges to be quoted.	Tender clause remains the same. Financial bids quoting "Nil" consideration or Zero percent or its derivatives upto 0.9999 percent and thereof as service charge shall be rejected summarily.
2	Wages for the supervisor to be paid by the University	As per the tender document, Supervisor shall be appointed and paid by the Service Provider.
3	How many days CUTN will take clear our monthly payment	University will take all efforts to clear the payment in time.
4	No of manpower quoted in the tender is not enough for covering the entire area mentioned in the Tender document.	Requirement of Labour Manpower is arrived as per the CPWD manual. However the total number of manpower under the contract is as per the discretion of the University and guidelines from UGC/Ministry of Education during the period of contract.
5	Machineries & Tools may be provided for Gardening and Housekeeping Services.	Cleaning Materials will be provided by the University for Housekeeping services. Minor Tools and implements shall be provided by the university for Gardening Services.
6	What is the age limit for the manpower to be outsourced?	Age limit is 19 to 58 years. The agency should deploy healthy and medically fit personnel. Periodical medical checkup will be done by the University.
7	Is there any penalty if the service provider not submitted the bill in time?	The claim bill has to be submitted in time.
