01-GENERAL TERMS & CONDITION

1.1 Applications are invited for empanelment of contractors for civil, electrical and garden works from any individual, sole proprietorship firm, partnership firm, public limited company, cooperative labour and construction society for execution of works upto Rs. 5 lakhs. The empanelled contractors have to abide by all the instructions made herein and as amended from time during the empanelment.

02-APPLICABILITY

- 2.1. Any empanelled are contractors who intended to work with Central University of Tamil Nadu Thiruvarur. It is done to have a ready stock suitable and competent contractor for University works so as to minimize the requirement of verification of credentials of contractors at the time of individual tenders, at the same only those contractors are allowed to continue that remain active and perform well.
- 2.2. Any contractor is initialled to get empanelment in University provided the eligibility criteria any other conditions should satisfy. The empanelled contractors have to abide by all rules made here in and as amended from time to time during empanelment.
- 2.3. Any contractor having such individual as one of the partner /Directors who is dismissed as Govt. Servant on whose empanelment have been cancelled, demoted to lower class, or having business band/suspended by any Govt. Dept. in the past or connected by a court of low shall not be entitled for empanelment.
- 2.4. Any Engineers or other official employed in Engineering or Administrative duties in the Engineering Dept. of the Govt. of India / State Govt. or Central /State/PSU. is not allowed to work in this University either as contractor or as employee of contractor for a period of one year after retirement from service unless he has often prior permission on the consultant employer to do so.
- 2.5. A contractor is not permitted to have empanelment in more than one name.

03-SCOPE OF EMPANELMENT

3.1. The contractor empanelled with Central University of Tamil Nadu Thiruvarur shall only empanelled for being considered for issue of tender document. To the terms & condition of individual notice inviting tender for each specific work shall not confirm any right on the contractor either to be necessarily issued tenders or award of work.

- ➤ Should provide copies of clearance/ Audited balance sheet/ Annual IT returns of last consecutive 3 years (any one of above).

Note:

- (*) "Completed works" means,
 - (a) **Civil:** Experience in Building construction works or Repair/ maintenance works of buildings or Interior works in Educational buildings/Institutional buildings/Public buildings/Hostels/Government quarters.
 - (b) **Electrical:** Experience in Electrical works (New & repair works, Installation, Testing & Commissioning of LT & HT, etc) in Educational buildings/Institutional buildings/Public buildings/Hostels/Government quarters.
 - (c) **Garden:** Experience in Garden development/ Horticulture works or Landscape works in Educational buildings/Institutional buildings/Public buildings/Hostels/Government quarters. Technical qualified agency should make a presentation before Financial bid opening.
 - Work Completion certificates issued by Competent Authority will only be considered. Competent Authority means officer not below the Rank of Executive Engineer/ Equivalent would be acceptable. Necessary documentary proof like "Work Completion Certificates" in case of works carried out for Government Departments and "TDS" in case of works carried out for private parties should be enclosed in addition to the work completion certificates.
- 6.2 The criterion for work experience, in case of empanelment, shall be the satisfactory completion of requisite number of Civil/ Electrical/ Garden works, as the case may be, of prescribed nature and magnitude executed on independent contract basis during the last Seven years w.e.f. the date of receipt of application for empanelment by appropriate authority. The works should have been executed in the same name and style in which the empanelment is sought.

- 6.3 The Comprehensive maintenance (with or without operation) works will be considered only if they have at least one of the following component for Electrical contractors.
 - a) Electrical installation.
 - b) Sub-Station.
- 6.4 Experience of contractor shall be reckoned upto the date of receipt of the application in the designated office, for works done, original of attested copies of certificates from the officers, not below the rank of Executive Engineer or equivalent, under whom works were carried out, should be enclosed in prescribed Performa. In case of photo copy, the same shall be attested (in original) by contractor.
- 6.5 The financial soundness shall be judged on the basis of the Banker's Certificate (solvency) as the case may be, issued by the Bankers of the contractors on the format (attached herewith as Annexure-IV) such certificate shall be issued by a scheduled bank and shall be submitted, in original, addressed to the authority to whom the application for empanelment is to be submitted.
- 6.6 The criteria for empanelment/revalidation shall be as applicable on the date of empanelment/revalidation.

07-EMPANLEMENT PROCEDURE

- 7.1 The Contractor shall have to submit the application in a prescribed form (Annexure-1(A) for Civil works), (Annexure-1(B) for Electrical works), (Annexure-1(C) for Garden works) complete with all documents as listed in (Annexure-II) to the O/o. The Registrar (i/c), Central University of Tamil Nadu, Thiruvarur.
- 7.2 The Name (s), address (es) of the applicant (s), telephone numbers, & email-ids shall be mandatory and their appearing in various documents should be consistent.
- 7.3 In case of incomplete application so if the applications are not accompanied with necessary documents the same are liable to be rejected by the authority receiving the empanelment application.
- 7.4 All verification, submission of report etc. are to be pursued by the applicant. Any delay on account of delay in verification, submission of reports, replies etc, will not entitle applicant for any type of empanelment.
- 7.5 If the empanelment authority finds the contractor suitable for empanelment, shall be issued empanelment order, against the application to the contractor, the decision of the empanelment authority shall be final and binding on the contractor.
- 7.6 The empanelment authority reserves the right to limit of contractors to be empanelled or any other manner decided by the department.

08-ELECTRICAL LICENSE (FOR ELECTRICAL CATEGORY)

8.1 The contractors of Electrical category shall have to produce valid electrical license having permission to carry out the work on HT line or LT line or both HT/LT Line from the competent authority in the name of contractor. They shall keep valid license throughout the period of empanelment by getting it renewed at suitable intervals and submit an attested copy of the same to the empanelment authority after each renewal. For applying tenders for a work they shall have to possess electrical license of appropriate voltage issued by any State Govt. under section 45 of India Electricity Rules 1956 or as amended from time to time.

09-PERIOD OF VALIDITY OF EMPANELMENT

9.1 The empanelment shall be valid for a period of **Three (03) years**. The empanlment can, however, be revalidated in accordance with rules in this regard. Each revalidation shall be for a period of one year from the date of expiry of the previous Empanelment/Revalidation. The empanelment

shall be opened to review by the empanelment authority and liable for termination, suspension of any other such action at any time, if considered necessary, by the empanelment authority, after issuance of show cause notice.

10- PERFORMANCE REPORT.

10.1 The contractor should fill up the details of works of appropriate magnitude, completed during seven years, in the Performa as given in "Annexure-III"

11- INTIMATION REGARDING CHANGE OF PERMANENT ADDRESS

- 11.1 While applying for empanlment, the contractor should mention the address of his registered office as well as head office. All documents i.e. Banker's Certificate, experience certificate etc, should bear one of the above addresses, otherwise the same shall not be accepted.
- 11.2 The contractor shall intimate the change, if any, in any of the above address, in advance of maximum within one month of such change along with acknowledgement of noting down of such change in address from the Bank, Income Tax, GST authorities etc. Failure to do so may result in removal of his name from the approved list of contractors.

12-DISCIPLINARY ACTION/DISQUALIFICATION/ SUSPENSION OF BUSINESS.

- 12.1 The contractor shall abide by all the rules of empanelment, and also by the terms and conditions of notice inviting tenders, etc. He shall execute the works with due diligence and strictly as per the conditions and specifications.
- 12.2 If required, the Empanelment Authority under his/her discretionary will appoint a committee to inspect the list of works submitted in the application with regard to quality, timely and satisfactorily completion etc. and shall have right to take disciplinary action against the Contractor, after the issuance of Show Cause Notice. The decision of the CUTN, Thiruvarur shall be final and binding on the Contractor.
- 12.3 Whenever report related to adverse performance, misbehaviour, direct or indirect involvement in threatening, making false complaints, filing legal suites for frivolous reasons, suppression of facts/information while bidding for works, hampering tendering process or execution of contract, or any act, omission or commission damaging the reputation of University officer, or any other type of complaint considered serious by the empanelment authority is received from any officer of CUTN against an empanelled contractor, he shall be served with suitable show cause notice by the empanelment authority, and thereafter action fore suspension of business may be taken by the empanelment authority, as deemed fit, pending full enquiry into the allegations.

The suspension of business shall automatically lapse at the end of 6 months from the date of suspension if the enquiry is not completed and final decision is not taken by the empanelment authority within this period.

The empanelment authority shall issue order for suspension of business with the contractor for a specified period if any of the charges are established on enquiry by the Empowered Committee. The suspension of business would entail ban on participation in the tendering process and award of contract for works during the period of suspension. It is made clear that if the contractor stood lowest in tenders received prior to the date of suspension of business, the work shall not be awarded to him, and the tenders shall be rejected and re-invited.

13. CANCELLATION OF EMPANELMENT

The empanelment of contractor may be cancelled, if he:

(a) fails to execute a contract or executes or executed it unsatisfactorily; or

- (b) violates any important conditions of the contract; or
- (c) fails to abide by the conditions of empanelment; or
- (d) is found to have given false particulars at the time of empanelment; or
- (e) has indulged in any type of forgery or falsification of records; or
- (f) changes constitution of the firm without the prior approval of the empanelment authority; or
- (g) changes the name of the entity without the prior approval of the empanelment authority; or
- (h) changes permanent address/business address without intimation to the empanelment authority; or
- (i) is declared or is in the process of being declared bankrupt, insolvent, wound up, dissolved or partitioned; or
- (j) violates the labour regulations and rules; or
- (k) is involved in complaints of serious nature received from any source, which have been proved; or
- (l) defaults in settlement of tax dues like income tax, GST, etc.; or
- (m) ceases to fulfill eligibility criteria based on which empanelment was done; or
- (n) does not start the work after the same is awarded to him on two occasions; or
- (o) fails to rectify construction/structural defects within a reasonable time not exceeding 1 month, pointed out to him by the engineer-in-charge from the date of completion of work; or
- (p) Any type of forgery or falsification of records, or,
- (q) Quoted for a tender under two or more firms where he is partner/ Director/Owner/GPA holder.

14- REVISION OF RULES

14.1 CUTN, Thiruvarur reserves the right to modify, add, and /or delete and /or change either whole or part of the Empanelment Rule without any notice and the same shall be binding on the contractors empanelled with CUTN, Thiruvarur.
