Central University of Tamil Nadu, an institution setup by an Act of Parliament, invites sealed bids from the authorized distributors/dealers/resellers for disposal of scrap materials (e-waste / general / electrical items / misc. items) at Central University of Tamil Nadu on "As-Is-Where-Is" basis. The tender documents can be downloaded from <u>www.cutn.ac.in/tenders</u>.

The documents should be enclosed in an envelope of appropriate size and should be sealed. The bid should contain (i) Covering Letter, ii) Technical Bid, iii) Financial Bid, iv) Supporting Documents and V) EMD or valid EMD exception certificate and duly super scribed as **Tender for disposal of scrap materials at CUTN -Tender Notice No.2023-24/04** 

A declaration as per prescribed format – Annexure –A should be kept inside the Envelope along with EMD of Rs.10,000/- and sealed. The tender must reach to Officer-In charge, Purchase Section, Central University of Tamil Nadu, Neelakudi Campus, Thiruvarur 610 005 by post or by hand on or before 05.06.2023, 15:00 hours.

Tenders received after due date/time will not be considered under any circumstances. Canvassing in any form will result in the disqualification of the bidder. Tenders sent by fax/email will not be considered. To avoid any complications with regard to Late Receipt/Non-Receipt of Tenders, it may please be noted that responsibility rests with the bidder to ensure that the tenders reach the above mentioned address on or before the due date.

Late bids i.e. bids received after the specified due date and time of receipt shall not be considered.

## 1. ELIGIBILITY CRITERIA

- 2.1. Companies/Bidder should be in existence for over 3 years in the business of lifting scrap materials.
- 2.2 . The firm/company should have two similar experiences for lifting of scrap materials during the last five years with a Government Department/Public Sector Undertaking. The company should furnish two contract documents with a Govt. office within the last five years.
- 2.3. The Vendor should submit an undertaking with the Bid to the effect that the firm has not been black listed by any of the Departments/Organizations of the Government of India and no criminal case is pending against the said firm on the date of submission of this bid (Prescribed Proforma as per Annexure D).
- 2.4 The vendor must furnish details of GST No/PAN No. and copy of these documents should be enclosed along with bid document.

2.5. The firms should have valid authorization certificate from Tamil Nadu Pollution Control Board (TNPCB) for Disposal of scrap materials (e-waste / general / electrical items / equipments / misc. items etc.).

## 2. EARNEST MONEY DEPOSIT (EMD):

The Bidder shall furnish, as part of its bid, an EMD of Rs.10,000/- by Demand draft drawn in favour of Central University of Tamil Nadu payable at Thiruvarur

- 3.1. The firms who are registered with National Small Industries Corporation (NSIC) / Small Scale Industries (SSI)/ Micro, Small and Medium Enterprises (MSMEs) are exempted to furnish the EMD. Self-attested photocopy of valid registration certificate issued by competent authority for disposal of Waste Papers must be enclosed with the technical bid.
- 3.2. Any bid not accompanied with the EMD shall be rejected by the Purchaser as nonresponsive.

#### 3. PROCEDURE FOR SUBMISSION OF THE BID

The vendors desirous of participating in the tender process shall have to submit their bids in two parts, viz., Technical Bid as per Proforma at Annexure -C and Commercial Bid as per Proforma at Annexure- D. Any overwriting/cutting/fluiding should be authenticated by the signatures of the individual, who has signed the Bid. Non-adherence will lead to rejection of the Bid.

**a.** <u>**Technical Bid</u></u> - All the columns, in the proforma of Technical Bid (Annexure- C) should be duly filled and supporting documents must be enclosed with this Bid. Incomplete Bid shall not be considered and will be summarily rejected.</u>** 

**<u>b.</u>** Commercial Bid- The Commercial bid format is provided along with this tender document. All columns of the proforma should be correctly and clearly filled.

The vendors will have to quote for all items included in Annexure- 'D'

In case if the same is found to be tempered/modified in any manner, tender will be completely rejected and EMD would be forfeited. CUTN reserves the right to accept or reject any bid or cancel tender proceedings without assigning any reason whatsoever. Incomplete quotations are liable to be rejected. In case of any discrepancy between rates mentioned in figures and words, the latter shall prevail.

Conditional tenders, on whatsoever ground, shall not be accepted and shall be summarilyrejected. Any attempt of direct or indirect negotiation on the part of the bidder with the authority who is competent to finally accept it after the submission of the tender; or any other endeavor to secure any interest or any influence by the bidder by any means for acceptance of a particular tender will render the bidder liable to be excluded from consideration. The Bids must be submitted on or before the due date. Bids submitted after the due date & time will be rejected.

#### 4. **BID EVALUATION CRITERIA:**

The Bids shall be opened by the authorized representatives of CUTN in the presence of representatives of bidders, if available. The date and time for opening of the Bids is given on the first page of this document. The Bidders may depute their representatives for the Technical Bid opening event.

The Bids will then be evaluated by CUTN, internally. The rate quoted by the eligible bidders will be considered for further process. The H1 bidders will be arrived at by calculating the total cost of all the Waste/ Scrap material. The H1 bidder will be awarded the contract for lifting of the Waste/ Scrap material.

H1 shall be evaluated on total amount inclusive of taxes as mentioned in the Commercial bid Format. If the price offered by that H1 bidder is not acceptable to the University, negotiation may be held with the successful bidder. The decision of the Competent Authority, CUTN shall be final and binding.

## 5. <u>SITE VISIT:</u>

Bidder(s) may inspect the articles/items, from 24<sup>th</sup> May 2023 to 26<sup>th</sup> May 2023 during Office hours (9.30am to 6.00pm) of this University before submitting their offer by the last date specified. The Bidder(s) should send a prior intimation in this regard by email/Phone (<u>purchase@cutn.ac.in</u> / Contact No. 04366 - 277359). The intending bidders, after inspection of items, bidder should quote a price or an amount which the firm is ready to pay for the scrap offered for sale in a sealed bid.

## 6. TERMS AND CONDITIONS

- 1. Bid should be signed by bidder(s) himself/herself/themselves or a person duly authorized in his/her behalf. A copy of such authority should be enclosed along with the bid.
- 2. Any tax is leviable shall be paid by the successful bidder.
- 3. All articles/items will be sold on "AS IS WHERE IS BASIS" (Item wise) will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quantity of the articles/items proposed to be auctioned.
- 4. The condemned/scrap items/articles will be sold to the highest bidder. The bidders shall quote the rate for the category wise list of the articles enclosed as Annexure B along with this tender document.
- 5. The successful bidder will be required to make full payment of bid by way of Demand Draft / Banker's Cheque payable at State Bank of India, CUTN branch, Thiruvarur in favour of Central University of Tamil Nadu payable at Thiruvarur after the finalization of the bid.
- 6. The highest bidder has to submit the amount within three days from the date of receipt of Award letter and if fail, the earnest money will be forfeited.
- 7. The successful bidder will have to lift the articles/items in his own cost, risk and arrangement after confirmation of payment.
- 8. The successful bidder will not be entitled to resell any of the articles/items while they are still lying within the premises of this institute and no delivery would be effected by this Office to any person or person(s) other than the bidder whose name/names are mentioned in the Order.
- 9. In case the H1 party fails to uplift items/equipment within the stipulated period, this University has the discretion to award the contract to H2 party on H1 rates. CUTN is not bound to give any notice / reminder to H1 party for their failure to deposit the quoted

price or remove / uplift machines/equipment within the stipulated period. In such case the EMD of the H1 party will be forfeited.

- 10. Sealed Envelopes should contain the tender form and the cover should be super scribed as "Tender for Disposal of scrap materials (e-waste/furniture/general/electrical items/misc. items)" addressed to the Officer In-charge, Purchase Section, Central University of Tamil Nadu and to submit on or before 05.06.2023 at 03.00pm This office shall not be responsible for any delay.
- 11. No bid shall be accepted after the due date and time. If the due date is happening to be a holiday the bid due date will be next working day at the same time notified as above.
- 12. Bids will be opened on the same day i.e, 05.06.2023 at 04.00pm. If the opening date is happening to be a holiday the bid shall be opened in the next working day of the same time in the Purchase Section, CUTN.
- 13. The tender shall be subject to the Indian laws and jurisdiction of the courts located in CUTN, Thiruvarur.
- 14. The firms should have valid authorization certificate from Tamil Nadu Pollution Control Board (TNPCB) for disposal of scrap/e-waste materials
- 15. The undersigned reserves the right to postpone the date of opening or accept or reject any or all the bids without assigning any reason at any stage.
- 16. In case of any difference / discrepancy between the rates quoted in figures and words, the later shall prevail.
- 17. A copy of this Tender Document with each page duly signed by the authorized signatory (who has signed the Bid),
- 18. The bidder shall quote the Technical and Commercial bids only as per the format enclosed at Annexure-'C' and Annexure- 'D'.
- 19. Conditional bids shall not be considered and will be rejected out-rightly at the first instance.
- 20. The quoted price, item-wise, shall be submitted in the Price Format at Annexure 'D', forming part of the Tender.
- 21. The tender shall remain open for acceptance for a period of sixty (60) days from the date of opening the bids. In case of withdrawal of tender within this period, the EMD remitted by the bidder will be forfeited.
- 22. The bidders are required to indicate their GST/PAN Number in their offer.
- 23. Tenders submitted without fulfilling the above term & conditions and in contravention to the tender notice are liable to be rejected summarily.
- 24. All statutory payments, like minimum wages prescribed, compensation in case of accident or loss, etc., to the workers employed by the bidder for the removal of the items shall be borne by the bidder.
- 25. The sale is subject to all terms and conditions prescribed in the tender document and resultant sale order.
- 26. CUTN reserves the right to accept/reject any/all tender(s) without assigning any reason whatsoever.
- 27. Any clarification required may be obtained before submission of the tender.
- 28. CUTN reserves the right to cancel the sale at any time without assigning any reason before issue of the sale order. BIDDERS are not entitled to claim any damage or compensation in case of such cancellation.
