Subject: Display of Provisional Answer Keys, and Question Paper with Recorded Responses for Answer Key Challenge for Common University Entrance Test [CUET (UG)] – 2023 – Reg.

National Testing Agency conducted Common University Entrance Test [CUET (UG)] - 2023 from 21 May 2023 to 23 June 2023 in Nine phases in 387 cities across India and 24 cities outside India for about 14,90,000 candidates.

The Question Papers with Recorded Responses **will be available by today evening** on the website <https://cuet.samarth.ac.in/> for all candidates who appeared for CUET (UG) – 2023 to challenge.

The candidates, who are not satisfied with the Answer Key, may challenge the same by paying a fee of ₹ 200/- (Rupees Two Hundred only) per question challenged as a **non-refundable** processing fee. The details for Answer Key Challenge are given below:

The payment of the processing fee may be made through, Debit card/Credit Card/Net Banking/Paytm up to **01 July 2023 (up to 11:50 P.M.)**. No challenge will be entertained without receipt of the processing fee. **The Challenges will not be accepted through any other medium.**

Challenges made by the candidates will be verified by a panel of subject experts. *If the challenge of any candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly.* Based on the revised Final Answer Key, the result will be prepared and declared by mid-July 2023. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. The key finalized by the Experts after the challenge will be final. **No challenge will be accepted after 01 July 2023 (up to 11:50 P.M.)**.

Challenges accepted against any Answer Key will be applicable to all candidates who would have attempted the corresponding Question.

ANNEXURE 1

PROCEDURE FOR CHALLENGE OF ANSWER KEY

1. Please go to the website <https://cuet.samarth.ac.in>
2. Login with your **Application Number, Password, or** Login with **Application Number and Date of Birth** and enter the Security Pin as displayed, and click on the Login Button.
3. Click the 'View/Challenge Answer Key' button.
4. The Option(s) next to the **Question ID** under the column '**Correct Option(s)**' stands for the most appropriate Answer Key to be used by NTA.
5. If you wish to challenge this option, you may use any one or more of the Options given in the next five columns by clicking the check box
6. You may want to upload supporting documents in which you can select 'Choose File' and upload (**all documents are to be put in a single pdf file**).
7. After clicking on your desired **Option(s) ID for Challenge** scroll down and click on '**Submit and Review Claims**' and move to the next screen. You must ensure to select all the required options(s) before moving further.
8. You will see a display of all the **Question ID** and **Option(s)** you have challenged. You may still modify your selection by clicking on 'Modify Claim'. Once you have selected all the **Option(s) ID for Challenge** you can click on '**Save Claim and Pay Fee**'.
9. Click on '**Save Claim and Pay Fee**' to select payment options. **No modification will be allowed after payment.**
10. Select the Mode of Payment and Pay a **non-refundable** processing fee @ **₹ 200/-** for each question challenged. Make payment through Debit/Credit Card/Net Banking/Paytm.
