MEMORANDUM OF THE ASSOCIATION

1. **NAME OF THE ASSOCIATION:** The Association shall be named as the “Central University of Tamil Nadu Alumni Association” (hereinafter referred to as “CUTNAA” or the “Association” as the case may be) and it’s a Non-profit Association.

The ‘CUTNAA’ is proposed herewith in accordance with Ordinance 35(1) of the Central Universities Act, 2009 (Act No. 25 of 2009) to connect the alumni to the CUTN for providing a valued service to the members and to assist in achieving the mission of the CUTN.

2. **DEFINITION CLAUSE:**

Association: The occurrence of the term “Association” shall mean the Central University of Tamil Nadu Alumni Association (CUTNAA).

Bye laws: The bye laws developed for governing CUTNAA under the Tamil Nadu Societies Registration Act, 1975, shall be amended by simple majority of the General Body of CUTNAA as and when necessary.

CUTNAA: The association of alumni of Central University of Tamil Nadu shall be registered under the Tamil Nadu Societies Registration Act, 1975 as a ‘Society’.

CUTNAA Fund: The CUTNAA Fund or the funds of the Association are meant those funds that are brought into the accounts of the Association. Further, all the money received in the form of membership fee, subscription fee, donation and other sources, etc. shall constitute the Fund of the CUTNAA.

Executive Committee: The Executive Committee (EC) is the governing body and shall be elected by the General Body for the purpose of carrying out the day to day activities of the CUTNAA.

Quorum: The minimum number of members required for a meeting to be conducted or a resolution to be passed as per the quorum mentioned in the Bye Laws.

Member Registry: The Member Registry can be defined as the register that contains the names, address and occupation of the members of the CUTNAA and the Secretary is bound by his/her duties to maintain it.

3. MISSION AND OBJECTIVES

3.1 To connect the alumni to the CUTN for providing a valued service to members and to support the mission of the CUTN.

3.1.1 To act as a good will ambassadors of CUTN within and foreign nations;

3.2 To promote the academic, professional interactions and networking among the CUTN Alumni.

3.2.1 To encourage alumni to share knowledge and expertise in areas pertaining to academics, infrastructure and industry interactions to the CUTN fraternity and as well as Alumni of the Association in the form of symposia, seminar, conference, workshop, discussions, etc.

3.2.2 To organize events and activities that foster relationship with the CUTN and sharing cultural aspects;

3.2.3 To give prizes and awards to University faculty, students/ unique research articles by alumni / service to the society / entrepreneurial related other achievement by the alumni.

3.2.3 To publish a news bulletin once in a year.

3.3 To facilitate and encourage alumni to contribute to the academics and research through allocating/raising funds and/or sharing knowledge and expertise to the CUTN Fraternity including Student community in areas pertaining to academics, infrastructure, industry interactions and any other area that the alumni and the CUTN feel appropriate.

3.3.1 To encourage the alumni members, non-members, Governments, Universities and other institutions, and philanthropists by raising the subscriptions, contributions, donations and gifts to achieve the objective of the Association.

3.3.2 To develop the infrastructure of the University in general or for a specific purpose including renovation of old buildings and build new ones.

3.3.3 To assist the University in the arena of automation, digitalization and modernization of libraries.

3.3.4 To provide fund for purchase of equipment and machineries and their maintenance.

3.3.5 To create a website for dissemination of alumni association activities to members and donors and its maintenance.

3.3.6 To render financial assistance to economically backward students and students from disadvantaged sections who is pursuing their degree course at the CUTN.

4. REGISTRATION AND EXISTENCE: The Registered Office of the Association shall be situated at the Administrative Block, CUTN Campus, Neelakudi and the activities shall be carried out through this office.

Date of Inception: The date of inception of the CUTNAA is on 17th May 2022.

Business Hours: The Business hour of the society shall be between 9.00 am to 1.00 pm and 3.00 pm to 5.00 pm on University working days only.
