3. Assistant Professor (Selection Grade / Academic Level 12) to Associate Professor (Academic Level 13A)
4. Associate Professor (Academic Level 13A) to Professor (Academic Level 14)
5. Professor (Selection Grade / Academic Level 14) to Senior Professor (Academic Level 15)

***4th Amendment Regulation 2024 is not applicable for the faculty members for whom CAS promotion has already been awarded.**
