Sub: Tamil Nadu Government Post-Matric Scholarship-SC/ST Fresh & Renewal Students – 2024-25-reg

The Tamil Nadu SC/ST Welfare Officer, Thiruvavarur, informed the eligible students to follow the instructions for applying the Tamil Nadu Post Matric SC/ST Scholarship during the academic year 2024-2025:

1. The student's name, gender, and date of birth in Aadhar Card must match with 10th and 12th grade. If not, the student's name should be corrected on the Aadhar card to match with the school certificates.
2. Fresh/Renewal students must obtain the online generated Income and community certificates.
3. The student must have the bank account in the name of the student. In such cases, it should be ensured that the bank account number is in use.
4. It must be verified that the name in the students' bank account matches the name on their school certificates.
5. Students must be ensured that the bank account is seeded and linked with the Aadhaar number.
6. To receive Direct Benefit Transfer (DBT) to the student's bank account, it must be verified whether the Aadhaar number is linked with NPCI through the website <https://resident.uidai.gov.in/bankmapper>.
7. If the student's Aadhaar number is not linked with NPCI, it is advised to contact the respective bank manager.
8. If there is a need to change the previous bank account number linked with the student's Aadhaar number, the new bank account details that need to be linked with the Aadhaar number must be submitted to the branch manager of that bank along with the previous bank account details linked with the Aadhaar number.

9. It must be ensured that the mobile number linked with the student's Aadhaar number is active.
10. If the parents/guardians of students applying for the scholarship are employed under the Central/State Government, they must submit an income certificate (Pay Slip) from their employer and an income certificate from the Revenue Department (Income from all sources - excluding HRA) to the educational institution.
11. The notification to apply for the SC/ST scholarship will be notified, after the portal enables the provision to apply for the scholarship for this academic year.
12. Eligible students are requested to check the Tamil Nadu Government SC/ST scholarship website <https://ssp.tn.gov.in/> from time to time to apply for the scholarship.
