Any degree from a recognized University with a minimum of 50% marks for EWS/OBC (Non-creamy Layer) and 45% marks for SC/ST/PWD candidates at the graduate level.

- ✓ Please note that only those candidates who register before the LAST DATE (28.07.2026, until 11:55 PM) for the open counseling will be considered for writing the **Entrance Examination**.
- ✓ Based on the responses received and the entrance examination, a merit list will be prepared for the above-mentioned vacancies, and admissions will be given on a merit basis.
- ✓ The Department will conduct the Entrance Examination on **29.07.2026** at **10.30 a.m.** in the Department of Tourism and Hospitality Management, CUTN.
- ✓ The number of vacancies is tentative only.
- ✓ Please note that the Expression of interest for this open counseling does not mean that the applicant is selected for the programme.
- ✓ The entrance examination shall follow the CUET PG 2026 syllabus and Question pattern.
- ✓ No ST candidates reported for the open Counseling-I, ST seats could be converted to SC seats.
