Eligibility Criteria: Candidates must have successfully completed the Higher Secondary Examination (10+2) or its equivalent from a recognized Board. A minimum of 50% aggregate marks is required for General/EWS/OBC candidates, while 45% aggregate marks is required for SC/ST candidates.

- ✓ Based on the responses received and the entrance examination, a merit list will be prepared for the above-mentioned vacancies, and admissions will be given on a merit basis.
- ✓ The Department will conduct the Entrance Examination on **07.08.2026** at **10.30 a.m.** in the Department of Tourism and Hospitality Management, CUTN.
- ✓ The number of vacancies is tentative only.
- ✓ Please note that the Expression of interest for this open counseling does not mean that the applicant is selected for the programme.
- ✓ The entrance examination shall follow the CUET UG 2026 syllabus and Question pattern.
