- (ii) It was explained that purpose of Pre-Bid Conference is to explain the various important provisions of the bidding documents to the prospective bidders and to clarify the queries that the bidders may have in the subject, bidding documents.

The technical queries and clarification sought by the prospective bidders are given as under:-

Sl. No	Query/ Clarification Sought	Reply to the Query
1.	Item No: 4 - Whether it is Spin Bike or Recumbent bike	Item No: 4 is Stationery Cycle - basic belt brake resistance system.
2.	Item No: 5 - Different weight kg in all workouts.	In Multi Gym 9 Stations, we are in the need of different weight stacks in a particular workout.
3.	Item No: 6 - Is it Hydraulic or Manual type.	Cable Cross Over machine is only available in hydraulic type.
4.	Thickness of weight lifting bar?	25-28 mm and weight plates are round in shape, mention in the specification clearly.

The committee felt that there is no need for revision in the specifications, hence recommended to stand in our technical specification.




The bidders were informed to ensure that all mandatory documents / certificates / undertakings are enclosed with the bids, as specified in the tender document.
